Guideline of Registration

1. Eligibility criteria for Registration of supplier firms.

All reputed firms/Agencies having a sound financial back ground, who are in the business of manufacturing, stocking or marketing of nutritional supplements & veterinary medicine as mentioned in the registration documents, are eligible for registration subject to specific conditions or restrictions stipulated in this proposal. They are as follows:-

- i). Attested photocopy of the up to date manufacturing licence of the manufacturer
- ii). Attested photocopy of the valid drug license for the items from competent authority.
- iii). Attested photocopy of VAT/TIN/GST registration certificate as per GST rules.
- iv). Attested photocopy of Authorization Certificate from the manufacturer for supply of veterinary medicine/nutritional supplements in case of authorised representative/distributor/Agency.
- v). Attested photocopy of In-house Research & Development (R&D) facility duly registered with Department of Science & Industries Research, Ministry of Science & Technology, Govt. of India.
- vi). Attested photocopy of Market Standing Certificate from concerned State/Central Drug Control Authority.(Chartered Accountent in case of imported drugs & feed supplements supported by copies of concerning invoices) confirming manufacturing/marketing of the offered products continuously for at least three year prior to date of notice for registration.
- vii). Attested photocopy of documentary evidences in support of minimum annual turn over of Rs. fifteen crores for preceding three years in supply of items of veterinary medicines/feed supplement.
- viii). Affidavit regarding not blacklisted by any Dairy Coperative Organisations/State Milk federation (format enclosed).
- ix). Detail Name, Address, Telephone No. Fax No., Mob. No., Email of the form & of the proprietor/Managing partner/Director must be mentioned in registration form at the place mentioned.
 - A. The partnership firm should produce attested photocopy of partnership deed.
 - B. The companies should produce attested copy of incorporation certificate.
- x). Experience certificate (along with copies of GST bill) illustrating minimum five year experience of supplying veterinary medicine/feed supplement to Dairy Coperative Organisations/State Milk federation with good track record.
- xi). Relevant ISO Certificate/GMP compliant Certificate.
- xii). Attested copy of PAN Card.
- xiii). Bank Details.
- xiv). Details of brochure, leaflets towards each veterinary medicine.
- xv). Attested photocopy of income tax return for the last three assessment year.

2. Benefits of Registration.

The firms/Agencies registered with Mithila Milk Union, Samastipur will have following priviledges.

- a) Tender enquiries against demands which are not advertised are sent to the registered firms.
- b) In case of advertised tender enquries, copies of tender notices may be sent to registered firms giving then advance information to enable then to purchase the tender sets.

3. Categoriwise list of Veterinary Medicines/feed supplements.

Managing Director, MMU, Samastipur reserves all rights to modify or add any or all the categories as per the Milk Union requirement from time to time.

4. Registration Procedure

- 4.1 The applicants for vendor/supplier registration should read, sign & agree to terms & conditions contained in all the pages of guideline containing registration document.
- 4.2 Firms having an Annual turnover of minimum Rs. 15 crores per year for last three years are eligible to apply for the registration.
- 4.3 Correct/relevant information/data have to be furnished by the vendors/supplier. Any wrong or misleading information given by firm, detected at any stage, shall render the vendor/firm for de-empanelment.
- 4.4 The applicant should make sure before applying for registration that it fulfils the required eligibility criteria.
- 4.5 Vendor/suppliers seeking registration shall have to pay the requisite processing fee of Rs. 500/- along with application form. The application form can be downloaded from the website of Mithila Milk Union, Samastipur (mmu.mithiladairy.com).
- 4.6 The amount shall be paid by a demand draft drawn in favour of Mithila Dugdh Utpadak Sahkari Sangh Limited Payable at Samastipur.
- 4.7 Suppliers shall have to fill and submit the hard copy of downloaded & completed Registration form along with required documents and processing fees through Speed post/Registered post to Managing Director, Mithila Dugdh Utpadak Sahkari Sangh Limited, Samastipur Dairy, Industrial Area, P.O Harpur alowth, Distt Samastipur 848101.
- 4.8 Applications incomplete in any respect viz. non-submission of any required document or information or fees in requisite amount may be liable for rejection.
- 4.9 The sealed envelope containing the Registration Form, documents & fee should be clearly super-scribed on the top of the envelope as "APPLICATION FOR THE VENDOR/SUPPLIER REGISTRATION FOR THE VETERINARY MEDICINE/FEED SUPPLEMENT".
- 4.10 The vendors/firms shall be considered for registration on the basis of satisfying eligibility criteria as depicted in point 01 of guideline as mentioned above with all supporting certified/attested copy of documents and payment of due fees. The manufacturer will be preferred to his authorized representative for this.

- 4.11 The attested/certified essential documents (as applicable) listed in point 01 should accompany the registration form, demand draft & covering letter in the letter head pad of the vendor to Managing Director, Mithila Milk Union,
- 4.12 After getting all the required fee, information and documents from the applicant, the Registration Number will be issued to the supplier/Firm.

5. Terms & Conditions for registration as a supplier/Vendor.

5.1 General Clause

Samastipur.

- i. The said registration qualifies a particular vendor/supplier for consideration for issue of tender paper in case of limited tenders for relevant category only for which vendor is registered. However, this will not give any claim to the party for an award of purchase order.
- ii. Managing Director reserves the right to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of Managing Director in respect of registration of parties shall be final & binding on all concerned.
- iii. Vendors once registered, shall have to promptly reply to all the enquiries, excute order as per the order as & when placed.
- iv. This document is treated as a valid contract between Mithila Dugdh Utpadak Sahkari Sangh Limited, Samastipur and Vendor and adherence to all the aspects of fair trade practices in executing the purchase orders placed by Mithila Milk Union from time to time during the registration period.
- v. In case, Registered Supplier is found in breach of any terms & conditions (s) or supply order, at any stage during the course of supply, suitable legal action as per rules/laws, shall be initiated against the vendor besides debarring and blacklisting the vendor concerned for at least three years for futher dealings & forfeiture of EMD.
- vi. The vendor should not assign or sublet the registration or any part of it to any other vendor in any form. Failure to do so shall result in termination of registration. All those firms which are registered and confirmed shall be entertained for various queries.
- vii. All registered firms are expected to maintain absolute integrity, follow a decent standard of business ethics and do nothing unbecoming of a registered supplier. In all future correspondence with Mithila Milk Union, Registered vendors are required to quote the Registration No.
- viii. Managing Director has all the rights reserved to add/delete/alter any of the items and to amend/add any of the terms and condition included in the registration awarded to the Vendors/firms with effect from any date, without assigning any reason(s) for the same.

5.2 Price Variation Clause.

During the validity of registration period including the extended period, if the vendor sells any item to any other department/Organization at a price lower than the price at which sold to Mithila Milk Union, Samastipur, the vendor must voluntarily pass on the price difference to Mithila Milk Union, Samastipur. On the body of the Voucher, the supplier will have to certify that, "The items being supplied through this voucher have not been supplied to any other organization at lower rates than this.

5.3 Indemnity

The selected vendor shall indeminify the Mithila Milk Union, Samastipur against all third party claims of infringement of patent, trademark/copy right or industrial design rights arising from the use of the supplied items or any part thereof. Mithila Milk Union, Samastipur stand indemnified from any claims that the vendor's manpower may opt to have towards the discharge of their duties in the fulfillment of the purchase orders.

5.4 Termination of the Registration of defaulter (Vendor/Supplier).

- a. Default is said to have occurred
 - i.If the vendor fails to deliver any or all of the services/ordered goods/items within the time period (s) specified in the purchase order or any extension thereof granted by Mithila Milk Union, Samastipur.
 - ii. If the vendor fails to perform any other obligation (s) under the registration.
 - iii.If the vendor/supplier does not respond to tender inquiry of this Milk Union more than 3 items during the contract period.
- b. If the vendor, in either of the above circumstances, does not take remedial steps with in a period of 15 days after receipt of the default notice from Milk Union (or takes longer period in-spite of what this union may authorize in writing), MD of Mithila Milk Union, Samastipur may terminate the registration/purchase order in whole or in part.
- 5.5 All disputes in this connection shall be under Samastipur jurisdiction only.
