

- The offer must contain GSTIN, HSN Code registration numbers necesserily failing which offer of the party will be summarily rejected.
- (2) The rate should be quoted inclusive of all taxes with its breakup, if applicable. All statutory liability of taxes, duties will be of the supplier and will be born by them unless it is specifically indicated in the offer.

The rate should be indicated on FOR Animal Feed Production Centre, Tajpur (Samastipur).

- (3) Our payment terms shall be 90% within 15 days of receipt of the ordered quantity. Rest 10% After NDDB LAB report. Deduction (if any) will be made on the basis of quality report as per quality parameter mentioned in offer & purchase order.

In case the quality differs from the specifications mentioned in the purchase order the consignment may be rejected or deduction as per the discretion of the purchase committee of the Milk Union. In case of rejection the inferior material needs to be lifted back by the party within fortnight beyond which Milk Union would have the liberty to dispose of rejected material without assigning any reason or any kind of payment to the vendor.
