Payment against all the accepted supplies will be made by respective Unions / Dairies for the each supply.

Vaishali, Samastipur, Darbhanga, Aarah, Gaya, Jehanabad, Muzaffarpur, Begusarai, Bhagalpur, Banka, Munger, Saran, Saharsa, Purnea) etc. in Bihar and Ranchi in Jharkhand as per ordered specifications and delivery schedule stipulated in the purchase orders issued by COMFED / Milk Union. The delivery will be taken both in cryocans as well as storage tanks.

2. Basic rates, applicable duties /taxes shall be indicated separately. Rate must be valid for 12 Calendar months from the date of issuance of Annual Rate Contract Order. Any price revision will not be entertained excepts of change in GST structure.
