

[A] DETAILED TERMS AND CONDITIONS OF THE TENDER DOCUMENT

- 1. The rates quoted by concerned suppliers shall be valid at least up to 20.04.2022 and they will have to supply the material at the quoted rate as per ordered specification and as per the delivery schedule stipulated in the purchase order.
- 2. <u>Cost of tender document</u>: Bidders have to submit a demand draft of Rs. 500 (Rs. Five Hundred only) non refundable towards cost of tender document non refundable in favour of "MITHILA DUGDH UTPADAK SAHKARI SANGH LTD, payable at Samastipur.
- **3.** Earnest Money Deposit: The parties have to submit a demand draft of Rs.5000/- (Five Thousand) only in favour of "Mithila DUGDH UTPADAK SAHKARI SANGH LTD", payable at Samastipur which shall be returned to the bidders after completion of this tender after deducting dues if any arises against this tender at the bidders cost & risk.

- **5.** Rates shall be quoted on FOR Mineral Mixture Plant, Tajpur and on gross weight basis as per enclosed format for different raw materials. weight would be considered.
- **6.** Bidder submitting the rate for less than 50% of the tendered quantity of materials shall not be considered.
- 7. Tenderers must indicate their GST, PAN registration nos. in the offer, failing which the offer of the bidder shall not be considered. Applicable taxes (if any) must be specifically indicated in the offer even if the net offered rate is tax paid. All statutory liability of taxes, duties shall be of the suppliers and shall be borne by them within the rate offered.
- **8.** The quantity required as mentioned in Annexure I may be changed based on requirements / availability of raw materials and its rate.
- **9.** Unions at its sole discretion may distribute the order quantity to more than one supplier without assigning any of order after discussion with relevant eligible successful bidder. During issuance of order after discussion with relevant eligible suppliers.
- 10. The excess/less quantity up to $\pm 10\%$ or maximum one truck load whichever is less shall be acceptable. But such relaxation would be under full discretion of Purchaser only.









- **11.** Our payment terms shall be 75% within thirty days of receipt of materials along with invoice & on physical verification and balance 25% on receipt of test report.
- **12.** The weighment of material shall be carried out at mineral mixture plant Tajpur or as arranged by the purchaser. The weight of the materials so received will be treated as final and binding to the supplier.
- **13.** Material to be suitably Packed to prevent damages or any pilferages during transit. The goods packed in torn or unsound condition of bags may be rejected or may face proportionate deduction.
- 14. The materials to be delivered strictly as per prescribed specification. In case of deviation, MDUSSL reserves full right either to accept the goods after imposing additional rebate beyond acceptable guidelines in accordance to the consent of supplier or issue directive to the supplier to lift the rejected goods after intimation either through letter/ mail or telephonic intimation too. In carrying out above task of either rejection or accepting the commodity with additional rebate, this should not demand any clarification or explanation from the supplier in subsequent period and the decision on above exercise adopted by Union would be final and binding to the supplier. Beyond the stipulated lifting time limit of 15 days from information to lift the materials, the rejected goods would be disposed of as per discretion of Union and no correspondence on same would be entertained. The cost of disposal would be recovered from the supplier account. Payments are likely to be held up if quality of the material found to be substandard.
- 15. Late delivery penalty: Union will have full discretion to receive the item and honour the order beyond the schedule date of delivery subject to prior approval from the Purchaser. In case the material is accepted after schedule date, the penalty will be imposed @1% of the total supply value for first 15 days other part of and 2% up to 30 days other part of after the due delivery date. The delivery of item beyond that needs further approval from Purchaser only.


